**Murdoch Spine

Students must complete 9 points in spine units. Historically, MSP100 was required to be completed. However, there are a range of units that can be used to fulfil that requirement. Refer to the University Handbook and timetable published in the academic year you intend to complete them. 2025 – CRM101, MSP100, MSP200, MSP201, MSP202, CRM310, CRM311, ART208, SIK102, GRD204, COM203, COM208

Criminology Units – 36 points

[Criminology Course Core Required Units \(9 points\)](#) – must take CRM303 and CRM307. (If you completed CRM306, you do not need to complete CRM303)

[Crime Science Major#](#) – Must complete 24 points – BIO388, BMS213, CHE103, CRM100, CRM120, CRM201, CRM203, CRM301. All units specified must be completed. NOTE: BIO388 is currently timetabled to run in WINTER. CRM301 is timetabled to run in SPRING.

[Criminology Specified Electives](#) – Students must take **6 points** of Specified Electives (see list in handbook under course code B1345).

Co-Major in Indigenous Knowledges and Practices (CJ-IKP) - 18 points

Students who elect to complete the co-major will need to use 18 points from the available 27 points of option / electives. SIK102, SIK200, SIK201, SIK300, SIK301, COD301

Minor in Indigenous Knowledges and Practices (MN-IKP) – 12 points

If students wish to complete a minor in Indigenous Knowledges and Practices, students must select SIK102 Wandju Boodja (Welcome to Country) and complete SIK200, SIK201 and SIK300 or COD301.

Notes:

- Do not exceed 10 units at level 100 (first year).
- The remaining 27 points can be comprised of a second major, co-major, minors or general electives – refer to handbook.
- Check the university timetable each year to confirm the teaching period units run as they are subject to change.
