This sample enrolment plan is based on the 2022 course structure and offerings. It is the responsibility of students to ensure the correct availability of units in each semester of each academic year.

This plan is for students enrolled full-time over the course of their degree. The expected workload for each 3-point units is 10 hours per week per unit. Students should consider all their commitments and factor the study workload level in when planning their course structure. Students studying part-time must meet the same requirements but over a longer period of time. For accreditation purposes, the Legal Practice Board of WA may require that your degree is completed within a shorter timeframe than the twelve years permitted under the coursework regulations. Students who may take longer than 10 years to complete their degree should seek advice from the Academic Chair.

Business Units:

Students should contact their Student Advisor or Business Major Chair for advice mapping out their Business Major units; this plan may need to be rearranged. Business Majors consist of 24 points in total (not including Business Required Units).
