The expected workload for each 3-point units is 10 hours per week per unit. Students should consider all their commitments and factor the study workload level in when planning their course structure. Students studying part-time must meet the same requirements but over a longer period of time. For accreditation purposes, the Legal Practice Board of WA may require that your degree is completed within a shorter timeframe than the twelve years permitted under the coursework regulations. Students who may take longer than 10 years to complete their degree should seek advice from the Academic Chair.</p>

<p><b>*Murdoch Spine: Career learning Units</b>  MSP100 runs in multiple teaching periods and can be completed in S1 or S2 of your first year. Students must complete 2 career spine units in addition to the compulsory first year MSP100 unit during their studies. There are a range of units that can be used to fulfil that requirement including many LLB units. You do not need to take the career spine units in the order suggested. You can swap the enrolment order of LLB specified electives and career spine units if you wish. Refer to the University Handbook published in the academic year you intend to complete them.</p>					
<p><b>** General Electives:</b>  Choose from any unit in the University where pre-requisite requirements are met (at level 100, level 200, or level 300).</p>					
<p><b>+ Law Specified Electives:</b>  Students must complete 24 points of 8 Law Specified Electives (8 units) during their studies. Some Law Specified Electives are 6 points.</p> <p>Law Specified Electives are also offered in non-standard teaching periods (such as summer, winter, and trimester teaching periods) and students may undertake Law Specified Electives in those periods instead of during semester.</p> <p>Students wishing to complete Honours should seek advice from the Honours Chair at the end of their second year.</p>
