Students must complete 24 points of 8 Law Specified Electives (8 units) during their studies. Some Law Specified Electives are 6 points.

Law Specified Electives are also offered in non-standard teaching periods (such as summer, winter, and trimester teaching periods) and students may undertake Law Specified Electives in those periods instead of during semester.

Students wishing to complete Honours should seek advice from the Honours Chair at the end of their second year.
