

## Purpose and Scope

Provide the procedure and responsibilities for Coursework admission. This procedure does not cover Short Courses or Master Classes.

This procedure applies to all staff, current and prospective students.

## Procedure

1. In this procedure, the following terms have the following meanings:
  - 1.1. “Agent” is defined in the [Agent Procedure](#).
  - 1.2. “Articulation Arrangement” is defined in the *Recognition of Prior Learning Procedure*.
  - 1.3. “Compassionate or Compelling Circumstances” are explained in the [Enrolment Procedure](#).
  - 1.4. “Confirmation of Enrolment” confirms the eligibility of an intending International Student Visa Holder to enrol in a Course.
  - 1.5. “Course” is explained in the [Coursework Regulations](#).
  - 1.6. “Coursework” is explained in the *Coursework Regulations*.

- 1.7. "Deferral" means an approved delay to the commencement of study requested by a student up to and including the first census date in their Course.
- 1.8. "Discontinued" is defined in the *Curriculum Procedure*.
- 1.9. "Exceptional Circumstances" are explained in the [Student Assessment Support Procedure](#).
- 1.10. "Exclusion" is defined in the [Student Integrity Regulations](#).
- 1.11. "Genuine Student" is defined in the [Student Progression Policy](#).
- 1.12. "International Genuine Student" means that a prospective student who seeks a student visa does so for the primary reason of studying in Australia.
- 1.13. "International Student Visa Holder" is defined in the [Admission and Enrolment Policy](#).
- 1.14. "Master Class" is defined in the *Non-award Study Procedure*.
- 1.15. "Microcredential" is defined in the *Non-award Study Procedure*.
- 1.16. "Nominated Guardian" is defined in the *Admission and Enrolment Policy*.
- 1.17. "Principal Course" is defined in the [International Student Transfer Procedure](#).
- 1.18. "Required Unit" is defined in the *Coursework Regulations*.
- 1.19. "Short Course" is defined in the *Non-award Study Procedure*.
- 1.20. "Suspended" means "suspension" as defined in the *Curriculum Procedure*.
- 1.21. "Transnational Student" is defined in the *Enrolment Procedure*.
- 1.22. "Unit" is defined in the *Coursework Regulations*.

### **Eligibility**

2. Prospective students must apply for admission:
  - 2.1. to a Course, with evidence that they meet the Course admission requirements
  - 2.2. to single Unit study, with evidence that they meet relevant Course admission requirements
  - 2.3. to a Microcredential with evidence that they meet admission requirements
  - 2.4. in accordance with the process and due dates specified on the University website.
    - 2.4.1. Prospective students who intend to be an International Student Visa Holder may need to apply via an Agent.
3. Course admission requirements will be in plain English, publicly available, accessible, and will include:
  - 3.1. academic entry requirements
  - 3.2. minimum English language proficiency requirements

- 3.3. non-academic Course specific requirements
- 3.4. any additional admission requirements required by a professional accrediting body
- 3.5. any other legislative requirements.
  - 3.5.1. An offer of admission does not guarantee a successful student visa application.
4. Microcredential admission requirements will be in plain English, publicly available, accessible, and will include:
  - 4.1. academic requirements
  - 4.2. minimum English language proficiency requirements
  - 4.3. non-academic requirements
  - 4.4. any other legislative requirements.
5. Admission requirements and processes are equivalent across campuses and attendance modes.
6. If admission requirements change, prospective students
  - 6.1. who have applied for admission and have not yet been made an offer, will be advised, and have their eligibility reassessed against the new requirements
  - 6.2. who have already been made an offer will not have their eligibility reassessed.
7. Intending International Student Visa Holders under the age of 18 at the commencement of study will only be considered for admission where:
  - 7.1. they have an approved Nominated Guardian or
  - 7.2. a supplier is approved to provide accommodation and welfare arrangements for the student in accordance with legislative requirements.
8. A prospective student who has had their enrolment cancelled by any higher education provider or who has been excluded from a higher education provider's campus:
  - 8.1. will be considered for admission if the cancellation or Exclusion period has ended before the start of study
  - 8.2. must explain how the issue that led to the cancellation or Exclusion has been addressed.
9. A prospective student who has a history of repeated failure at any higher education provider must explain how the issue that led to the failure has been addressed.

### **Offer of Admission**

10. Prospective students:
  - 10.1. may be issued an offer of admission

- 10.1.1. to a Course, where they meet the Course admission requirements
  - 10.1.2. to single Unit study, where they meet the relevant Course admission requirements
  - 10.1.3. to a Microcredential where they meet the admission requirements
  - 10.2. are not guaranteed an offer of admission.
11. Prospective students who do not meet the Course admission requirements may be considered for admission if there is evidence they have a high probability of successfully completing the Course.
- 11.1. The rationale for the decision will be centrally recorded
  - 11.2. the student's progress will be monitored
  - 11.3. the decision may prompt a change to Course admission requirements.
12. Offers may be:
- 12.1. unconditional
  - 12.2. conditional
  - 12.3. subject to completion of one or more pathway Courses.
13. Prospective students must accept, defer or decline their offer of admission in writing and by the deadline.
- 13.1. International Student Visa Holders under the age of 18 also require the offer of admission be accepted by their parent or legal guardian.
14. A written admission agreement will be retained by the University for at least two years after the student ceases to be enrolled.
15. Deferral of admission may be granted for a minimum of one teaching period or a maximum of two years.
- 15.1. The maximum time period may be extended for a further 12 months at a time where there is evidence of Exceptional Circumstances.
16. Students who defer will be subject to the admission requirements, tuition fee structure and the Course version at the time of their revised commencement date.
17. Deferral may not be granted where the Course:
- 17.1. will not be available when the student wishes to recommence
  - 17.2. has a quota
  - 17.3. has specific Deferral conditions.
18. Where Deferral is initiated by the University the applicant will be notified in writing of the reasons and duration.
19. Intending International Student Visa Holders may be issued a Confirmation of Enrolment after accepting their offer, providing required documentation, and paying a deposit.

20. For International Student Visa Holders, where Deferral would require an extension to a Murdoch-issued Confirmation of Enrolment, it will only be granted if there are Compassionate or Compelling Circumstances.

### **Murdoch Course Transfer**

21. After accepting the admission offer, students who want to transfer to another Murdoch Course can apply via the standard admission process.
  - 21.1. Approval may only be granted twice where the change is initiated by the student.

### **Rescission or Refusal of Admission Offer**

22. An offer may be rescinded or refused, with reasons provided in writing, where:
  - 22.1. the prospective or current student:
    - 22.1.1. does not meet admission requirements
    - 22.1.2. did not formally apply in accordance with the approved process
    - 22.1.3. did not meet specified timeframes
    - 22.1.4. does not have a high probability of successful completion
    - 22.1.5. has not provided required information
    - 22.1.6. has been denied enrolment in a Required Unit of that Course
    - 22.1.7. has a history of failing to pay fees to any education provider
    - 22.1.8. has a history of poor engagement with a Course they were enrolled in at any higher education institution
    - 22.1.9. is not deemed a Genuine Student
    - 22.1.10. is not deemed an International Genuine Student
    - 22.1.11. is an International Student Visa Holder who has not completed six months of their Principal Course unless their admission is possible under legislative requirements (see the *International Student Transfer Procedure*)
    - 22.1.12. has provided fraudulent or misleading information to any education provider
    - 22.1.13. was offered admission based on inaccurate information provided by the student
    - 22.1.14. provided an unsatisfactory explanation following a history of cancellation, Exclusion or failure at tertiary level.
  - 22.2. a Course quota exists
  - 22.3. it is not viable for the University to offer a Course, Unit or Microcredential
  - 22.4. the Course or Unit to which the student has been admitted has been Suspended or Discontinued

- 22.5. admission may adversely affect the University community
- 22.6. admission of the student would be contrary to law
- 22.7. evidence could not be verified
- 22.8. the offer has been made in error
- 22.9. admission of the student is contrary to the Foreign Interference Policy.

**English Language Preparation Courses**

- 23. English language courses that are approved as being equivalent to minimum English language proficiency requirements are:
  - 23.1. centrally recorded
  - 23.2. independently and externally reviewed:
    - 23.2.1. where there is an identified risk
    - 23.2.2. where there is a curriculum change to the English language course
    - 23.2.3. where there is a change to Murdoch’s minimum English language proficiency requirements
    - 23.2.4. prior to approval.
